

Call to Action: COVID-19 Containment in Orange County Jails and Courthouses

Email and Call Script for OC Decision-Makers

Background: Our Orange County jails are the 9th largest populated in the country, with a daily average population of 5,400 people. Roughly 55% of people in OC jails have not been convicted but remain in jail because they are unable to afford bail. We are calling on the Orange County Sheriff's Department, the Orange County Health Care Agency, the Health Care Agency's Correctional Health Services, the District Attorney's Office, the Orange County Superior Court, the Orange County Housing Authority and the Board of Supervisors to **act immediately to protect the lives of the people impacted by our county's jail system.** This includes individuals in custody *and* jail staff, as well as their family members and communities.

Email and/or Call Script
